ELIGIBILITY

Your account must be current to be eligible for the Absolute Propane Credit Card/Debit pay program. You may not have had more than two separate return items (NSFs) within the prior 12 months. *Customer must be signed up for Budget Billing if "Checking or Savings account" is selected.*

TERMS AND CONDITIONS

By completing the Absolute Propane Automatic Credit Card/Debit Pay authorization form, you authorize Absolute Propane to debit your credit card/checking account each month prior to the payment deadline. Your payments will be debited from your credit card/checking account prior to the payment deadline. Please review your statement/invoice for accuracy. Absolute Propane Will be responsible for correcting statement/invoice errors if written notification from you is received within 60 days of the statement/invoice date in which the error occurred. You understand and agree that Absolute Propane is not liable for incorrect debits to your account resulting from errors on your statement/invoice. Absolute Propane has the right to terminate this payment option at any time. **You may discontinue this service at any time with 30 days advance written notice to Absolute Propane.** This authorization does not alter in any way the terms and conditions of the Absolute Propane Master Agreement for Propane Sales and Equipment Rental. Absolute Propane is not responsible for any financial institution or credit card fees as a result of this program or other indirect, consequential, or incidental damages, including fees for account adjustments or overdrafts.

RETURN ITEM POLICY

If any automatic payment is returned unpaid or declined by your financial institution for any reason, Absolute Propane may charge and you agree to pay a Fee of up to \$25 or the maximum allowable fee under applicable state law, whichever is less. All charges, terms, and conditions are subject to change.
